4. Speaking Time: **3+2**

-3 minutes speaking time -2 minute rebuttal time.

(Participants are requested to adhere to the time frame, lest there be negative markings.)

4. Participants are requested not to read out from prepared speeches.

5. Each participant can be subjected to **2 questions** for **rebuttal**.

(Short and precise questions to be asked based on the content of the participant

No Counter-question)

6. Participants shall get their sides chosen by the organizers, **4 days** before the competition.

7. The session will be held via **ZOOM MEETING**. It is mandatory for the Participants to have their **audio and video enabled** on their device while speaking.

8. **DRESS CODE:** Participants are requested to adhere to the formal dress code (**BLACK AND WHITE**) during the Competition.

9. The **decision** of judges shall be **final**.

10. The **winner** shall be declared on the same day.

11. Marking will be on the basis of:

- **Content**
- **Fluency**
- **Rebuttal**
- **Overall Involvement**
