Details regarding mode of conducting the upcoming Online semester examination is as follows:

1. The question papers for the said examination will be uploaded in the Official website of Calcutta University and also in the Website of the College 30 Minutes before the schedule time of examination as per the schedule of the University.
2. Duration of the examination will be three hours.
3. All examinees shall submit/upload their answer script within 30 Minutes from the time of completion of the examination in the respective e-mail addresses created by the College for each subject semester wise. 5. Students should use A4 papers as answer scripts. In front page of the answer scripts students have to write:
  - (i) University Roll Number and Registration Number;
  - (ii) Name of the Examination (5-year B.A.LL.B. Examination/ Semester/ Honors);
  - (iii) Name of the subject and paper number;
  - (iv) Date of Examination;
  - (v) University Roll Number must be written in each page of the answer script;
  - (vi) Each page of the answer script must be numbered consecutively, e.g.; 1,2, 3... and so on;
  - (vii) The answer script must be uploaded/sent in single PDF file preferably within 10 MB. The name of the PDF file will be University Roll Number.

Any willful or deliberate delay in uploading the answer scripts (files) without proper reason will be dealt with in strictest manner. Normally hard copies of answer scripts are not encouraged by the college. However, in case of students who do not have access to internet or fails to access internet due to any technical problem can submit their answer script in a sealed envelope with Calcutta University Roll Number and Registration Number, Subject and Paper Number written on the envelope to the college authority directly within 12 hours of completion of the examination. At the time of submission, the examinee should put his/ her signature on the receiving book available with the college authority.
