



## **DR. RAJARSI DAS**

#### **Bionote-**

DR. RAJARSI DAS began his academic career with above 85% marks (above 75% was Star Marks) in his first Board Examination i.e. Madhyamik (Class X) and received National Scholarship Award. He thereafter obtained the B.Sc(Hons) and M.Sc degrees in Zoology. His legal education was set in motion from Surendranath Law College, Kolkata where he joined the 5-year LL.B course. On merit, he was offered LL.B(Hons) curriculum and transferred to Department of Law (Hazra Campus), University of Calcutta. After earning the LL.B(Hons) degree, in the same year, his name appeared on the LL.M Admission Merit List. The University of Calcutta conferred upon him the LL.M degree. He was awarded Ph.D in law from the University of Burdwan for his legal research on "Intellectual Property Protection in Biotech Invention in India: A Socio-Legal Study". He completed two certificate courses also- 1. Information Technology Application and 2. Human Rights.

Dr. Das started his legal career as an Advocate of Calcutta High Court. He is now Assistant Professor of Law through West Bengal College Service Commission (WBCSC) and is the Teacher-in-Charge of Surendranath Law College, Sealdah, University of Calcutta while Vice Principal is in leave. Before joining Surendranath Law College, he served Jogesh Chandra Chaudhari Law College (almost one decade), Rabindra Shiksha Sammillani Law College, Midnapore Law College, Jyotirmoy School of Law. Dr. Das has also been serving as Visiting Faculty of Law in various Universities/Institutions. He teaches various subjects of Law (Research Methodology, Corporate Law, Cyber Law, Criminal Laws etc.) to Law students in LL.B and LL.B(Hons) as well as Lawyers/Advocates in LL.M curriculum. He has been acting as research guide / supervisor of dissertation papers, doctrinal, non-doctrinal legal research in LL.M curriculum. He has been entrusted with various

confidential works like Head Examiner, Paper Setter, Paper Moderator, Examiner, Scrutineer, Reviewer in Calcutta University, Vidyasagar University, Kazi Nazrul University, Brainware University etc. He has chaired and acted as resource person as well as presented various research papers in a number of National and International Seminars, Conferences, Legal Aid Camps etc. His articles have also been published in various journals, books, magazines etc. He has written various law books in his own credit. He has acted as OBSERVER of Govt. of West Bengal in SET of West Bengal College service commission (WBCSC) and TET of West Bengal Board of Primary education (WBBPE).
